4. First-aid measures

Description of first aid measures

Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. When breathing is difficult, properly trained personnel may assist affected person by administering oxygen. Place unconscious person on their side in the recovery position and ensure breathing can take place. Never give anything by mouth to an unconscious person. Get medical attention if any discomfort continues.

Ingestion

Remove affected person from source of contamination. Rinse nose and mouth with water. Give plenty of water to drink. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. Do not induce vomiting unless under the direction of medical personnel. Place unconscious person on their side in the recovery position and ensure breathing can take place. Never give anything by mouth to an unconscious person. Get medical attention if any discomfort continues.

Skin Contact

Remove contaminated clothing and rinse skin thoroughly with water. Continue to rinse for at least 10 minutes. Do not use organic solvents. Get medical attention if irritation persists after washing.
